### Welcome

Meeting called to order at 10:00 am.

## Agenda

## **Approval of Minutes**

Mary Chasseur moved to approve the April 26, 2017 Advisory Council minutes. Kathleen Naegele seconded. Motion carried.

## **Director's Report**

Bryon presented his report. Topics of note include:

- Federal funding is resolved for the current year. IMLS funding was reinstated. Everything is still up in the air for next year.
- State aid will be increased 12% to 36 cents per capita. This will also result in increased funding for the co-op density payments.
- Bryon attended a co-op directors' meeting in Marquette.
- Remember that we can ask for OCLC marc records through White Pine also don't forget that we can request materials that are not available in MeLCat through "Peabody" (White Pine's OCLC service.)
- We have five Board positions open for the next fiscal year. Replacements have agreed to serve.
- Our September 27, 2017 meeting will feature The Breton Group to discuss fundraising.
- Bryon will conduct two policy workshops this fall details to follow.
- Upcoming state legislation to watch: House Bill 4814 requiring all millages to be on the November Ballot, and Senate Bill 571 prohibiting those seeking millages from discussing the proposal with the public for 60 days prior to the vote. Both bills would be detrimental to libraries looking to pass a millage.

#### **Old Business**

- Special project RBDigital subsidy will be continued pending Board approval
- The co-op will have approximately \$10,000 to commit to another project this year. Suggestions include: Subsidizing attendance to the Rural Libraries Conference in May 2018, Scholarship to attend MLA conference, new office furniture for White Pine office, Strategic planning, marketing

#### **New Business**

• Jill Brown made a motion to hold our December meeting on the 13<sup>th</sup> and cancel if there is no pressing business. Mary Jaworski seconded. Motion passed.

#### **Overdrive Presentation**

Mike Evans from Overdrive introduced us to their new app: Libby. It is available for apple and android devices right now and soon will be released for kindles. It is a much easier to use, intuitive app. Overdrive will start heavily marketing Libby in late fall. The old interface will remain active for some time while patrons migrate to Libby.

Mike discussed options for libraries to share their advantage titles. We opted to enable this feature, but it is up to individual libraries to decide if they want to participate and under what parameters.
