**Welcome**

**Agenda**

Stephanie Olson moved and Emily Boersen seconded to approve the agenda. Motion carried.

**Approval of Minutes**

Stephanie Olson moved to approve the April 25, 2018 Advisory Council minutes. Sandra Johnson seconded the motion. Motion carried.

**Director's report**

Bryon presented his report. Some topics discussed were: Rural Library Conference budget; Penal fines, state budget and legislative bills; "Meet the candidates" schedule; a state-wide OverDrive access pilot; State Aid increase of 9%; Cooperative Directors' Association plans for a Bi-annual Libraries conference next spring, and held opposite years as the state Rural Library conference. **Old Business:**

**Special Project, \$15,000**

\$6200 went to Zinio. Several libraries mentioned that patrons aren't using Zinio as much as hoped. Ideas for remaining money, future special projects: Value Line or Morning Star (investment resources). Bryon will check into Coop-wide pricing. Mimi Herrington attended the RBDigital webinar and she received a personal Acorn TV subscription (British titles, Indie movies, Great courses, concerts). RBDigital is offering an Acorn TV subscription service to libraries. The library pays a platform fee and patrons can checkout a license for Acorn for 1-week for \$2.99. Restrictions can be setup by the library. Bryon will check into coop-wide pricing. Bryon suggested purchasing the Overdrive Business Collection for \$623. Money could be used to purchase extra copies of high demand, long hold time e-books.

**Overdrive**

MCLS and LM are looking into a state-wide Overdrive collection that will work like the Advantage+ collection. There are 32 different consortia in the state with Overdrive. Ebooks/audiobooks could be shared through the state. Priority is given to the owning library but if items are not being used, other library patrons could use.

**I wish my library ...questions.** There was only one response to the survey.

### **Budget**

The 2018-2019 budget is almost the same as this year. Bryon would like to have some strategic planning before committing extra money to other projects. More money will be added to the fund balance with the state aid increase.

### **Bi-annual Conference**

The Cooperative Directors Association (CDA) is planning to hold mini rural conference on opposite years as the Michigan Rural Libraries Conference. Cooperative will subsidize the funding. The first one is planned for May 2019, to be held in Gaylord. The nationally known Ben Bizzle will be asked to be the keynote speaker. Bryon would like to know how much White Pine can subsidize for the conference and members' attendance fees. This will be discussed at a future meeting. Nothing is finalized.
