February 4, I did a Board training session at the Brown City Public Library.

February 8, I attended the "meet and greet" for the new Director at Gladwin District Library, John Clexton

February 25, I met with the School Board of the J O Memorial Library, Kingston.

February the Cooperative Directors met in Lansing, part of the meeting was planning for the future of the CDA and how cooperatives can work together.

Updated Library Bill of Rights should be added to the WPLC policies.

Reminder that the 2020 census will be completely online. The Census Bureau is telling people to go to the library if they need a computer or help. It is to our benefit to ensure everyone is counted since our populations have been decreasing. Since so much funding is on a per capita basis, we want everyone counted.

On 4/26 I'll be in Lansing for the CDA meeting.

The Annual meeting is set for October 9, 2019, 10:00-4:00 at the Golden Glow Ballroom. Kris Rzepczynski will present on genealogy resources, Fred Schutmaat will discuss space planning and author Tom Carr will talk about his writings.

The Senate, yesterday, passed a road funding bill out of committee. It will implement the 2015 road funding bill a year early – by taking \$600 million out of the general fund. State Aid to libraries comes from the general fund. The Gov. has threatened to veto this bill.

HB 4326 Prohibits employer inquiries regarding criminal history before offer of employment is made. (Johnson, Cynthia A. (D), 03/12/19)

Prohibits certain inquiries and requests for disclosures during the hiring process; to provide for the powers and duties of certain state officers and entities; to provide for the promulgation of rules; to make appropriations for the implementation of this act; and to prescribe civil sanctions.

A bill to allow library employees or agents to carry and administer opioid antagonists in certain circumstances; to provide access to opioid antagonists by certain libraries and library employees or agents; and to limit the civil and criminal liability of certain libraries and library employees or agents for the possession, distribution, and use of opioid antagonists under certain circumstances.

SB 0200 **HEALTH, Other**, Allow opioid antagonists prescribers to prescribe and pharmacists to dispense to public libraries under certain circumstances. TIE BAR WITH: SB 0199 (Wojno, Paul (D), 03/12/19)

Amends 1978 PA 368 by amending section 17744b (MCL 333.17744b), as amended by 2016 PA 384. Both REFERRED TO THE COMMITTEE ON HEALTH POLICY AND HUMAN SERVICES

HB 4392, EDUCATION, School Districts, Requires certified library media specialist and instruction on literacy, information research, and technology standards in all public schools. (Camilleri, Darrin (D), 03/19/19) Amends 1976 PA 451 (MCL 380.1 to 380.1852) by adding section 1162. REFERRED TO THE COMMITTEE ON EDUCATION

HB 4393, EDUCATION, School Districts, Requires school library and participation in interlibrary loan system in all public schools. (Koleszar, Matt (D), 03/19/19) Amends 1976 PA 451 (MCL 380.1 to 380.1852) by adding section 1161. REFERRED TO THE COMMITTEE ON EDUCATION

HB 4394, EDUCATION, School Districts, Provides for designated individual to supervise pupils in a school library under certain conditions. (Pagan, Kristy (D), 03/19/19) Amends 1976 PA 451 (MCL 380.1 to 380.1852) by adding section 1162a. REFERRED TO THE COMMITTEE ON EDUCATION

The Trial Court Funding Commission has reported that funding for trial courts is "broken". It states that the courts should not have to raise funding for themselves and is urging the legislature to come up with a funding formula.
