Director's Report August 26, 2020

**STATE AID** There was good news last week that the deficit may only be \$1.0-\$1.5 billion as opposed to \$3.5 billion. Then the Consensus Revenue Estimating Conference met this past Monday on August 24. The new revised deficit is estimated at \$926 million, which is better than originally thought. However, fiscal year 2022 may be a harder year as this year federal funds were used to help with the State's budget.

**STAFF UPDATE** Sheila is working Tuesday, Wednesday and until noon on Thursday. Jane works from home her 15 hours, and I am in the office M-F from 8-4. If you call the office and get our voicemail, it will go to our email and we will call you back.

**QUICKBOOKS** We are going to switch our QuickBooks subscription to the online version so I can have access in real time as well as Jane who will continue to do all the bookkeeping.

**MCDA (MI Coop Dir Assoc)** The letter to Library Board Trustees providing information, showcasing educational opportunities, and highlighting all the resources at LOM will be mailed to each Board Chair by the middle of September. Prior to that mailing, a copy of what is being sent out will be emailed to each Library Director.

**CARO OFFICE** We have been in our new office for 2 months and have sold a few more items for a total of \$740.00. It cost the coop about \$2,200.00 to move. This included the actual movers and moving, cleaning supplies, a mini fridge, and new furniture. A desk was left in the space, so we were able to find one that matched and purchased that for Sheila. We start to pay rent September 1. Since we did not have to pay rent for July and August, this saved the coop \$3,400.00. Rent in Saginaw was almost \$1,700/mo. and now it is \$500.00, a savings of \$1,200/mo. Insurance will also wind up costing approximately \$600.00 less a year.

**PPE COSTS** Thirty-seven White Pine members ordered PPE through the coop. The total cost was nearly \$10,000. So grateful you were able to pay for this initial purchase with CARES Act grants for ppe. What does \$10,000 worth of ppe look like?

**DIAL-A-STORY** I sent this information with last week's update. The cost is \$1275 for the first year and \$900/ yr. after. If this is something members are interested in let me now ASAP so we can see if there is interest and I may be able to get a better discount.
