**BOARD MEETING**  
**Minutes February 24, 2021**

*A meeting of the White Pine Library Cooperative Board was held on February 24, 2021 via Zoom meeting.*

**Treasurer's Report:** The Board reviewed the financial reports and checklist. Bills were routine in nature.

**Amend Budget:** Kate Van Auken proposed amending the 2020-2021 Budget since it was originally created with a 30% reduction to State Aid. The proposed amended budget shows an increase of \$61,772.00 to income and an increase of \$31,950.00 to expenses. The largest increases to expenses are for Special Projects which is proposed to include paying for BookPage and eMagazines with OverDrive, and Continuing Education which is proposed to include \$300 per library for programming/continuing education of their choice.
