**Welcome!** Thank you for joining me at Frankenmuth Wickson District Library and Happy Library Appreciation Month!

**State Aid** The 2020 populations are not available at the moment, but MI Treasury will be working on downloading to the LOM payment system when they have the information. The LOM has used the old populations to open up the State Aid reporting period. Before any payments will be made, after February 1, 2022, the new population figures should be available. I am currently working on the State Aid report for the Coop as well.

**QuickBooks** White Pine QuickBook account numbers have been updated to comply with the new standards. We are ahead of the deadline which is next year based on our FY.

**Audit** Our audit is scheduled for November 8.

**H.O.P.E. Grant (Round 2-Michigan Humanities)** The Coop was awarded a \$5,835.00 HOPE Grant which will cover about 30% of the cost for emagazines for OverDrive members in 2022. Seven White Pine member libraries also received HOPE grants totaling \$62,435.00. Congratulations!!!

### **OVERDRIVE**

- Fees will be the same as last year as I was able to renew our contract with OD under the same terms we have last year. Billing to members will go out in November.
- A few member’s patrons have experienced an issue with the Libby app on older IOS devices. There was an internet encryption change on the web and it seems to be impacting older IOS devices. OD is working on its Help page to update customers about the situation. In the meantime, if you log into your OD Marketplace account and click on support, go to the bottom of the page, and click on technical support. You can then submit a tech ticket on your patron’s behalf. This way they can look at the individual device and exact issues your patrons are having.
