## **MDHHS Division of Environmental Health**

As part of their Care for MI Drinking Water Program, MDHHS recently launched a statewide pilot program encouraging private well maintenance. The "Well Assessed Project" invites well owners, living in the rural areas of our state, to complete a step-by-step inspection of their home's private well, to assess its condition and learn more about the quality of their drinking water. Participation takes about 10 minutes, and participants receive a \$20 Visa gift card as a thank-you for participating. The grant period for the project is ending and MDHHS is hoping you would be willing to promote the project among our state's well owners by posting the Well Assessed Project flier. I will send it out with the Weekly Update on Friday.

## House Bill 4817-Open Meetings Act

There has been no movement since the end of June. It has been referred to the Committee on Local Government and Municipal Finance. I will keep watching for movement.

In light of everything that has been going on in the library world, Foster Swift has created a much more detailed FOIA policy, and it might be worth your while to contact your attorney if you haven't updated yours recently.

### **Annual Meeting**

Our Annual Meeting will take place on October 4, 2023, beginning at 10 am at Trillium Banquet Center in Saginaw and ending at about 4 pm. The Board will meet at 9:30 before the beginning of the Meeting. Registration will open on September 5 and will close on the 26. The cost is \$25/per person. There **won't** be a remote option.
