Minutes, February 28, 2024

Welcome

The meeting was held at Alma Public Library in Alma, MI. Ruth Steele called the meeting to order at 10:02 a.m. There were 23 attendees at the meeting, and 12 attending via Zoom.

Introductions

New Business

OverDrive increase discussion

Kate Van Auken gave an overview of WPLC's OverDrive collection, its history, and funding levels. WPLC has a large amount of holds on digital materials (60% are on audiobooks, 40% on eBooks), and Kate is seeking ways to combat this. One option is to increase the cost per capita for participating members to \$.15 (up from \$.14). Another option would be to encourage all



participating members to utilize their Advantage accounts for their patrons and share these materials with the cooperative after they've circulated at their home library. No decisions about how to proceed occurred as this discussion focused on starting the conversation about how best to decrease holds now that RLA is active.

Kate Van Auken noted that WPLC would revisit this topic at Advisory Council meetings in the coming months.

Public Comments/Membership News:

Debbie Mikula, Executive Director, Michigan Library Association

Debbie Mikula spoke to WPLC members about the Michigan Library Association (MLA), numerous services offered to its members, the upcoming Advocacy Day on Tuesday, April 16, 2024, and MLA's MI Right to Read campaign. She outlined the priorities for 2024's Advocacy Day: the soon-to-be-announced Michigan Freedom to Read Act, a \$2M increase to State Aid, capital improvements funds, and amendments to the Open Meetings Act. She explained how current law protects MI librarians from prosecution for distributing library materials and how the new law would complement existing legislation. She also detailed the public opinion poll conducted by MLA in March 2023 on Book Banning and Censorship.
