Think Space Recap

Three directors from WPLC received a scholarship to attend MLA Think Space 2023 – 2024. They each shared a recap of their experience.

Michelle Duclos, Frankenmuth Wickson District Library, found great value in the chance to meet directors and connect with them. Discussions about Michigan's aging population were particularly

relevant for the district her library serves, and she took a lot away from sessions about utilizing the space and staff of her library to better serve the community.

Sara Morrison, Briggs District Library, also found great use in the discussions about aging, economic prospects, and opportunities for Millennial and Gen Z Michiganders. A session about succession planning was also important given the restrictions on upward movement in library spaces without a library degree.

Vicki Mazure, Harbor Beach Area District Library, reported that the discussions had about AI left her feeling less worried about its potential impact given that it will be some time before we know how the technology will impact society and the library profession. She also really enjoyed the chance to connect more personally with directors, particularly in more casual spaces that allowed directors to feel able to speak openly about their struggles.

Public Comments/Membership News:

Discussion was had about the "Ensuring Digital Accessibility" webinar held by LCM and Foster Swift on Tuesday, June 25th. Attendees reported getting useful information from the webinar.

Tessa Sullivan, Amazon Prime – What is new?

Tessa Sullivan, Amazon, spoke to members about new developments with the Amazon Prime for Business plan negotiated by TLN. She and her colleague, Brennan Ryan, spoke about updates to the "Your Business Account" section, best practices for navigating the interface, and some of the savings available to participants. Additionally, Brennan discussed new discounts on 2,500 book titles and the opportunity to negotiate prices for titles purchased in bulk (such as for book club). The "Books Only Voucher" feature was also demonstrated to show its potential use for book giveaways, literacy programs, or prizes.
