**BOARD MEETING**  
**Minutes, June 25, 2025**

A White Pine Library Cooperative Board meeting was held on June 25, 2025, at Fleschner Memorial Library in Birch Run, MI.

**Present:** Amy Beckman, Lynne Clark, Christian Dunham, Amber Hughey, Nicole Markel, and Marcy Thompsons. Also present was Kate Van Auken.

**Call to Order:** The meeting was called to order at 12:12 pm by President Nicole Markel.

**Approval of Agenda:** Marcy Thompsons moved, and Amber Hughey seconded to approve the Agenda as presented. The motion was carried.

**Approval of Minutes:** The April 2025 Board Minutes were presented. Lynne Clark moved, and Marcy Thompsons seconded to approve the April 23, 2025, Board Minutes. The motion was carried.

**Treasurer's Report:** The Board reviewed the financial reports and checklists for April and May 2025. Christian Dunham moved, and Amber Hughey seconded to approve the financial reports and ratify the April and May 2025 bills. The motion was carried.

Nicole Markel went through a summary of the Board's review of Kate as well as input from WPLC member libraries. Members shared high marks and positive feedback about the Director's performance.

Nicole had asked Kate about thoughts on compensation and discussion revolved around the health insurance stipend for her and Alison.

Amber Hughey moved and Christian Dunham seconded to give Kate and Alison each a 4% raise and increase Kate's insurance stipend to \$900.00/mo., and Alison's insurance stipend to \$700.00/mo. for the 2025-2026 fiscal year based on the upcoming budget review. The motion carried.
