WHO: White Pine members.

WHAT: White Pine will reimburse your library based on your library’s budget for organizational or individual membership(s) in the following Library Associations for the **2023-2024 fiscal year**.

HOW: Pay one, or more, of the Library Associations directly for organizational or individual membership in their organization, complete the attached form, and submit your receipt for payment to White Pine for reimbursement. Please note you will only be reimbursed up to the amount listed below. If you want to belong to all of them, great, but you will only be reimbursed up to your library’s allotted amount.

WHEN: 2023-2024 fiscal year dues.

WHY: The cost to belong to some library associations can be a major barrier to libraries. Because of this, White Pine wants to help eliminate that hurdle, so members have the opportunity to take part in networking, continuing educational opportunities, conferences, advocacy efforts, etc., that library

associations provide their members. White Pine wants you to get as much out of these resources as possible and hope you will take advantage of this service!

EXAMPLE:

Kate's Library expense budget is \$113,745.00 and the library's service population is less than 10,000. The amount Kate has to spend on library association membership(s) is \$299.00. She decides an organizational membership is better in her situation.

ALA organizational membership is \$175.00

ARSL organizational membership is \$125.00

MLA organizational membership is \$299.00

Kate decides to join ALA, ARSL, and MLA and purchase organizational memberships. The total cost is \$599.00. White Pine will reimburse Kate's Library \$299.00. Kate's library is responsible for the \$300.00 difference.

You can use the stipend for an individual membership or organizational membership. You can mix and match, you can add additional groups. For example, with ALA, you can also be a member of PLA along with your organizational membership. The choice is yours. Apply this amount where you want, turn in your form with your receipt to White Pine, and be reimbursed!

Make sure to refer to each Library Association website for their definitions of their organizational and personal memberships. For example, if you want to belong to Public Library Association (PLA), you have to also be a member of ALA.
